# a. Charity Care, Deposit & Discount Payment

President Hickman stated that by having a charity care policy in place, we can participate in the HRSA program. Facilities will have a HRSA score. SIHD is interested in the HRSA score. If we take on various practitioners and they are employed by a facility with a high score their education is reimbursed.

Treasurer Branson wanted to know if this has ever been used. Has the charity care been applied for in our facility? Shannon Jimerson, CNO stated that the Billing Office used to use it back in 2012- 2103 until the closure. SIHD didn't reenact when the facility reopened. No one has used it since the reopen.

Shannon is to correct the typo on page 47 referring to the public health department to Kern Valley.

Treasurer Branson asked if there is a time limit on the EMP evaluations.

Need the policy reviewed and approved to the committee then to the board annually.

The flow chart-incident command structure (page 25) there is a typo. It has Ridgecrest regional on top.

Per Shannon, she can't say who the incident commander because we never know who will be in the building when the disaster hits. The incident commander will always fall to the house supervisor until administration can get in.

There are binders around the facility which go over job descriptions that go over each specific roll. They are made up so that when a disaster hits a person can pull the manual and see the job descriptions and their rolls.
