II. BUSINESS ITEMS

A. Resolution 20-1 Paycheck Protection Program Loan

Peter Spiers explained that SIHD has started the process of opening accounts at Eastern Sierra Community Bank. In order to have the loan forgiven we need to use the whole amount of 1.2 million dollars for payroll. There is a small portion that SIHD can use for "other". All of the SIHD board members and Peter Spiers will be authorized signatories with Eastern Sierra Community Bank. Per Chet Beedle, Financial Consultant's request we will leave a 50k in the account.

The Paycheck Protection Program loan was unexpected. It was due to the change in the rural hospital and critical access who were in chapter 9 bankruptcy and who were not being eligible. SIHD received the maximum amount allowable. This is a huge benefit for SIHD.

Peter Spiers will be signed a DocuSign and will begin the process of opening the accounts today. During the biweekly payroll process we will wire monies from the new account into SIHD's Payroll account at El Dorado Savings Bank.

Per Chet Beedle, 75% needs to be for payroll and 25% can be used for "other". For example SIHD's health benefits.

Action: Secretary Roper moved to approve Resolution 20-1 Paycheck Protection Program Loan, opening of an account with Eastern Sierra community Bank with Peter Spiers and all SIHD board of directors as authorized signers of the account and authorizing Peter Spiers to send DocuSign to Eastern Sierra Community Bank for the loan. Vice President Carson seconded.
